FAST ACTION ROUNDUP® Ready to Use Weedkiller

ACTIVE INGREDIENT: Contains 7.2 g/L GLYPHOSATE as the isopropylamine salt in the form of a ready to spray liquid.

***1 hour visible effects for most weeds under optimal conditions (e.g. actively growing soft weeds, sunny conditions).**

PRECAUTIONS: READ LABEL BEFORE USE. AVOID RELEASE TO THE ENVIRONMENT. Avoid contact with eyes and skin. Wash hands after use. DO NOT allow pets and children to enter treated area until spray has dried. DO NOT allow container or spray to get into drains, sewers, streams or ponds. WHERE TO USE: For the control of most grasses and broadleaf weeds in garden beds, rockeries, driveways, paths, along fence lines, lawn edges, around buildings and prior to planting new lawns and garden areas. Do not apply on or around food or animal feed crops.

DIRECTIONS FOR USE: Apply when weeds are actively growing. Spray to wet all leaves. Weeds may be removed and/or planting may occur in treated areas 7 days after treatment. Perennial weeds may need a repeat treatment. DO NOT disturb weeds for 7 days after treatment. DO NOT spray if rain is likely within 2 hours. DO NOT use on frost damaged weeds or weeds covered with dust or silt.

CAUTION: DO NOT allow pets and children to enter the treated area until the spray has dried. Avoid contact with desirable plants, including turf grass, you do not want killed. If accidentally sprayed, hose off immediately with water to reduce injury.

STORAGE: Store in the closed, original container, in a cool dry place out of reach of children. DO NOT store in direct sunlight.

SHELF LIFE: When stored appropriately this product should show no significant degradation for 2 years from the date of manufacture. Contact your supplier for further information about the use of any product that is older than this.

DISPOSAL: Dispose of this product only according to the label or at an approved landfill, but ensure adherence to local regulations. Rinse empty container, puncture and recycle or dispose of safely with domestic rubbish.
